DATA PROTECTION INFORMATION

We hereby inform you about the processing of personal data by Familypark GmbH and the rights to which you are entitled under data protection law.

The personal data collected on this form are processed for the following purposes:

- Process your order for products or services. This processing is necessary for the execution of the contract that you conclude with Familypark GmbH, Märchenparkweg 1, 7062 St. Margarethen;
- Send you commercial offers, birthday cards (only for children younger than 14 years) and newsletters about products, services and events of Familypark. This processing is based, in the case of messages sent by Familypark, on the legitimate interest of the latter in developing its activities (if the email address to which these messages are sent was given when an order was placed unless you object to it) or on your consent (if the email address was given without any order); and in the case of messages sent by partners of Familypark, with your consent;
- Contact you in case of lost passes. This processing is based on the legitimate interest of Familypark;
- Comply to legal obligations such as e.g. tax law retention obligations;

The processing is carried out under the responsibility of Familypark, represented by Filip De Witte, acting in its capacity as General Director, whose contact details are Familypark GmbH, Märchenparkweg 1, 7062 St. Margarethen. The data collected is intended for Familypark GmbH and all service providers required to carry out the above-mentioned data processing operations;

DURATION OF DATA STORAGE

- Data collected to process your order for products or services: for the duration of the contract and further seven years, statutory retention period;
- Data collected to send you commercial offers, birthday cards (only for children younger than 14 years) and newsletters about products, services and events of Familypark: for three years after collection unless you have objected to it. At the end

of this period, this data is retained for a further period of three years if you agree to continue to receive commercial offers, birthday cards (only for children younger than 14 years) and newsletters about products, services and events of Familypark;

In order to preserve the confidentiality and security of your personal data and in particular to protect them against unlawful or accidental destruction, accidental loss or alteration, or unauthorized disclosure or access, Familypark GmbH takes the appropriate technical and organizational measures, in accordance with the applicable legal provisions. To this end, Familypark GmbH has put in place technical measures (such as firewalls) and organizational measures (such as a login and password system, physical protection means, etc.).

You have the right to access the data relating to you, to have them corrected or deleted, to transfer them or have them transferred to a third party, to obtain a restriction on their processing or to object to such processing. Familypark GmbH will comply with your request subject to compliance with its legal obligations.

You have the right to withdraw your consent to the processing of your data at any time. Withdrawal of your consent does not affect the lawfulness of the processing carried out prior to such withdrawal.

In the interest of confidentiality and protection of your personal data, Familypark GmbH reserves the right to ask you for proof of identity before replying to your request, in accordance with the provisions of Law No. 78-17 of 6 January 1978, known as the „Data Protection Act“, Article 92 of the Decree of 20 October 2005 as amended by the Decree of 1 August 2018, and European Regulation 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data. You may therefore be asked to produce a photocopy of an identity document stating your date and place of birth and bearing your signature.

Finally, you have the right to address a complaint to the Data Protection Agency if you feel that your rights are not respected.
